Sejak 2015 UI telah melakukan upaya hilirisasi dan komersialisasi Kekayaan Intelektual hasil riset yang dilaksanakan oleh dosen-dosen UI. Sampai saat ini telah terdapat 10 perjanjian kerja sama komersialisasi, dengan hasil komersialisasi berkisar 2-20 persen dari harga jual.

Since 2015, UI has made downstream efforts to commercialize UI lecturers' Intellectual Property. To date, there have been ten commercialization cooperation agreements, resulting in a royalty of 2-20 percent from its selling price.

Universitas Spin-Off

University Spin-Off

Universitas Indonesia mendorong peningkatan inovasi dan kewirausahaan di lingkungan Universitas Indonesia untuk membantu penyelesaian masalah nasional dan global. Salah satu yang dilakukan oleh Universitas Indonesia terkait hal ini ialah membentuk badan usaha di luar perguruan tinggi yang mengomersialisasikan hasil-hasil riset dan hasil-hasil inovasi (*spin-off*). Di Universitas Indonesia, pengupayaan hal ini dilakukan di bawah naungan Direktorat Inovasi dan Science Techno Park Universitas Indonesia (DISTP UI). Pada awalnya Direktorat ini bernama Direktorat Kerjasama dan Inkubator Bisnis (DKIB). Tugas pokok DISTP

Universitas Indonesia encourages increased innovation and entrepreneurship to help solve national and global issues. One of its contributions is to form a business entity outside the university that commercializes research and innovation results (*spin-off*). This effort is carried out under the Directorate of Innovation and Science Techno Park, Universitas Indonesia (DISTP UI). Initially, this directorate was named the Directorate of Cooperation and Business Incubator

UI ialah menjalankan kebijakan dan pengembangan inovasi, pengelolaan inkubator bisnis, dan proses hak atas kekayaan intelektual, serta pengembangan muatan kurikulum yang mendorong inovasi dan pengembangan kewirausahaan.

Sampai 2020, Universitas Indonesia mencatat 22 *tenant* DISTP yang juga merupakan Spin-off Universitas Indonesia. Ke-22 *tenant* tersebut ialah: Meetchange, Poci, Sikomo, Nano Biotek Indonesia, Mora, Signifier Games, Telehealth, PT Belimbang Island Indonesia, eClis, Travelia, utKliq, PT Matahari Nusa Kreasi (Cozora), Indves, Superjamu Herbachic, Weston, Instan Indonesia, Dattang, inFishta, Regen, Juragan Kapal, dan Flip.

(DKIB). The main task of DISTP UI is to carry out policies and innovation development, manage business incubators, handle intellectual property rights, and develop curriculum content that encourages innovation and entrepreneurial development.

By 2020, Universitas Indonesia has recorded 22 DISTP tenants who were also Universitas Indonesia Spin-Offs. The 22 tenants are Meetchange, Poci, Sikomo, Nano Biotek Indonesia, Mora, Signifier Games, Telehealth, PT Belimbang Island Indonesia, eClis, Travelia, utKliq, PT Matahari Nusa Kreasi (Cozora), Indves, Superjamu Herbachic, Weston, Instan Indonesia, Dattang, inFishta, Regen, Shipyard, and Flip.

memberikan fasilitas program inkubasi bisnis kepada perusahaan rintisan (*start-up*) dari mahasiswa, alumni, maupun peneliti UI yang telah terpilih melalui proses seleksi. Program inkubasi bisnis berupa pelatihan di bidang pengelolaan keuangan, pemasaran, pengembangan bisnis, *mentoring*, pameran, hingga *business matching*.

Selain memberikan fasilitas berupa peningkatan kualitas *start-up*, DISTP UI juga memberikan fasilitas berupa *coworking space* yang terdapat pada Gd. ILRC UI Lantai 2, Universitas Indonesia, Depok.

Pada 2019 dan 2020 DISTP telah memberikan program inkubasi kepada 33 *start-up* (2019) dan 8 *start-up* (2020).

DISTP UI, through the Subdirectorate of Business Incubator, annually provides business incubation programs to start-ups from UI students, alumni, and researchers who passed the selection process. Business incubation programs consist of training in financial management, marketing, business development, mentoring, exhibitions, and business matching.

Besides providing facilities to improve start-up quality, DISTP UI also provides a coworking space facility located in ILRC Building Floor 2, Universitas Indonesia, Depok.

DISTP has provided incubation programs to 33 start-ups in 2019 and 8 start-ups in 2020.
