

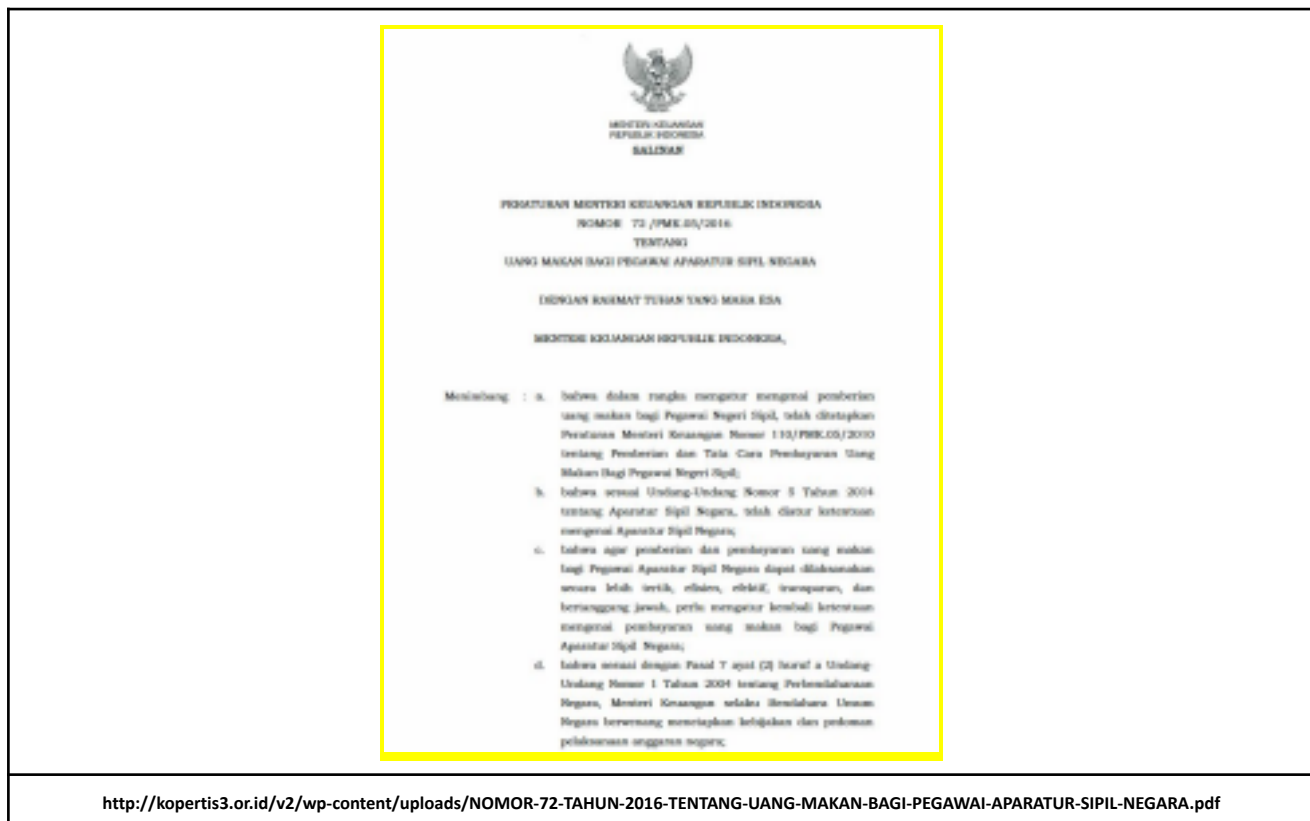

Description :

Universitas Indonesia regulates the attendance system and the provision of food allowances for the employees working in the university administration center as it is stated in the Rector's Decree No. 19 of 2021. Furthermore, the faculty also issued a Dean's Decree in order to subsequently support this regulation. It relates to the Minister of Finance's Regulation No. 72 of 2016 concerning the provision of food allowances for civil servants which supports the means of food supplies for employees and their family members.
