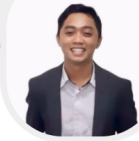

Duties and Obligations of MWA



Description :

Universitas Indonesia Board of Trustees (Majelis Wali Amanat - MWA), is the highest governing body at Universitas Indonesia. The board consists of elected representatives from student, faculty members, and non-faculty staff, as well as the government and society's representatives.

These general policies include budget and finance approval, ratifying the Long Term Development Plan (RPJP), Strategic Plan (Renstra), RKA, and evaluating each of their implementation. In addition, MWA is obligated to provide input to the Rector regarding the management of UI and the implementation of laws and regulations; assess the performance of Rector once a year, together with Academic Senate and Board of Professors, as well as appointing and dismissing the Rector of UI and resolving UI problems that cannot be resolved by other university organizations after going through coordination meetings with them.



MWA consists of 17 (seventeen) members consisting of:

1. Ministerial element: 1 person
2. Rector's element: 1 person
3. Lecturer elements: 7 people
4. Educational staff's element: 1 person
5. Student elements: 1 person
6. Elements from the community near UI: 6 people

Representatives from each element, both from the minister, rector, lecturers, education staff, students and the community are expected to contribute ideas for the progress of Universitas Indonesia.
