Commitment and consistency periodically and continuously carried out by FISIP UI in order to meet and facilitate infrastructure and institutional needs regarding education and community service related to a healthy campus by way of establishing a coordinating body, developing an action plan, implementing, monitoring and evaluating an action plan for continuous improvement.

- 1. The Central Administrative Unit of the Faculty of Operations and Facility Maintenance (OPF) has the responsibility of facilitating facilities and infrastructure related to occupational safety and health within the Faculty. OPF itself consists of several subunits including
 - Health and Safety Environment (HSE),
 - Facilities and Infrastructure,
 - Engineering,
 - Information and Technology Development Unit (IT Unit),
 - Environment, Campus Security Unit (Security Unit),
 - Fire Role Officers (Emergency Response Management FISIP UI)

- 2. Several other internal institutions are the Center for the Study of Sexual Violence, the Center for the Study and Advocacy for the Protection and Quality of Life for Children, the Institute for Socio-Political Research and Development (LPPSP FISIP UI) and so on.
 - In an effort to support safety on campus, FISIP UI has implemented an Occupational Health, Safety and Environment Management System (SMK3L) within the faculty.

Installing signage and repairing the installation of water terminal devices or called fire hydrants. Signage is a visual clue that contains certain information. In the FISIP UI, this signage is used for information regarding Health, Security and Environmental Safety (K3L) which is outlined in the form of posters which have now been distributed in all buildings. The contents of the poster provide information about evacuation routes, emergency response structures, evacuation procedures, important numbers and sanitation instructions.

Making this signage as a means of information regarding HSE to the FISIP UI community. The aim is to inform the FISIP community that there is an HSE procedure. If there is an emergency, this signage tells you what steps to take.

With this signage, students, lecturers and employees can respond when a disaster occurs and are able to know the procedures and steps that must be taken so they can stay safe and sound.

One of the other HSE supporting facilities is the existence of a fire hydrant. Fire hydrant is a water terminal that is used to help extinguish fires in the event of a fire.

Overall security facilities in the building are still good. The existence of smoke and fire detectors as well as fire alarms makes FISIP UI more alert in dealing with incidents that have the potential to trigger a fire.

Improving the quality of HSE support is one way to ensure the health, safety and security of the academic community in the FISIP UI campus area.

• Then regarding matters that are educational, research, development and community service related to healthy campus policies, most are carried out by other internal faculty institutions, namely the Center for the Study of Sexual Violence, the Center for Studies and Advocacy for the Protection and Quality of Life of Children, the Institute for Socio-Political Research and Development (LPPSP FISIP UI) and so on.
