**MEMORANDUM OF AGREEMENT

ON
ACADEMIC COLLABORATION**

UNIVERSITAS INDONESIA, a Legal Entity State University based on Government Regulation Republic of Indonesia No. 75 Year 2021, domiciled at Jl. Salemba Raya 4, Jakarta; in this matter represented by **Athor Subroto, Ph.D.** as the **Director of the School of Strategic and Global Studies**, pursuant to Delegation Letter of Rector UI Number 118/SP/R-SKSG/BLLH/2023, and now therefore lawfully acting for and on behalf of the School of Environmental Science of Universitas Indonesia (hereinafter referred to as "**SSGS-UI**").

and

JIANGXI UNIVERSITY OF FINANCE AND ECONOMICS, domiciled at No.168, East Shuanggang Road, Nanchang, Jiangxi Province, PR. China. In this matter represented by **Prof. Wu Zhaoyang, Ph.D** in his capacity as **Dean**, and therefore lawfully acts for and on behalf of **School of International Trade and Economics** , Jiangxi University of Finance and Economics (hereinafter referred to as "**SITE-JUFE**").

Both parties are collectively referred to hereinafter as the "**Parties**" and individually as the "**Party**".

PREAMBLE:

The parties agree

1. to enter into an agreement for academic cooperation;
2. that the academic cooperation will promote further educational collaboration and cultural understanding and agree to further continue their common interest in promoting the mutual cooperation in the area of education and research; and
3. to implement the MOA under the terms and condition hereinafter set forth.

NOW, THEREFORE, for and in consideration of their promises and undertakings, the Parties agree as follows:

ARTICLE 1
PURPOSE AND OBJECTIVE

- (1) The purpose of this Memorandum of Agreement is to make possible and to facilitate the exchange of students, scholars and educational resources between both Parties, as well as research and publishing collaboration, based upon principles of mutual equality and the reciprocity of benefits.
- (2) The objective of this Memorandum of Agreement is to strengthen ties between the Parties and to promote academic cooperation and to further cultural understanding in both countries.

ARTICLE 2
AREAS OF COOPERATION

The Parties agree to collaborate in the following relevant areas:

A. ACADEMIC AND NON-ACADEMIC STAFF PROGRAM

- (1) Visits by staff will be encouraged for the mutual benefit of Parties. Each Party will accept faculty members, researchers and non-academic staffs from the other Party. Suitable arrangements will be made for the exchange for collaboration in teaching, research and administration development in case-by-case basis;
- (2) The host Party will provide the proper services for exchange staff including access to laboratory facilities;
- (3) The host Party will assist, as far as possible, in arranging accommodation for the staff, and will assist the visiting staff in matters of immigration, stay and working permit, medical emergencies, language and local custom. The salary and international travelling expense will be sponsored by the sending party.

B. DUAL-DEGREE PROGRAM

The student dual-degree program will be detailed in a specific agreement. Initially, it includes,

- (1) Dual-degree program: Parties will develop the "3+1.5" or "3+2" Dual-degree program for JUFU students. Which refers to JUFU's undergraduate students study 3 years' bachelor degree in JUFU and 1.5 years or 2 years' master degree in UI, after completion they can obtain bachelor degree from JUFU and master degree from UI if they are qualified to graduate.
- (2) The program major(s) and benefits will be discussed and decided by both Parties after consultation.
- (3) This program may extend to UI's students in the future based on the Parties' cooperation.
- (4) More details of the program will be specified in other agreement determined by both parties.

C. ADVANCED EDUCATION PROGRAM

- (1) SITE-JUFU will recommend students to study for master or doctoral degree at SSGS-UI.
- (2) The program is for JUFU's students but not only limited to its students, students from mainland China are included.
- (3) The program major(s) and cooperation with a third party will be discussed and decided by SITE-JUFU and SSGS-UI after consultation.
- (4) More details of the program will be specified in other agreement determined by both parties.

D. COLLABRATIVE EDUCATION PROGRAM

- (1) The Parties agree to develop the collaborative education program, initially majored in International Business (Cross-border E-commerce) and Mandarin courses, if it gets approval from the authorities of both parties accordingly, and it may further develop other majors later on;
- (2) This program is operated at SSGS-UI jointly run by both Parties.
- (3) The enrollment will be Indonesian and Chinese student and the program language will be bilingual, English and Indonesian.
- (4) The program students will be conferred JUFE's master degree if they are qualified to graduate.
- (5) More details of the collaborative education program will be specified in other agreement determined by both parties.

E. JOINT RESEARCH PROGRAM

- (1) Joint research program is developed for mutual benefit of Parties.
- (2) SSGS UI agrees to support the "Belt and Road" Initiative Institute, SITE-JUFE, Indonesia Research Center. SSGS-UI will support JUFE's visiting scholars to conduct research in Indonesia. The details of specific research proposals will be determined by the mutual agreement of both Parties.
- (3) SITE-JUFE agrees to support the China Research Center in SSGS-UI, and Indonesia Research Center in SITE-JUFE. SITE-JUFE will support UI's visiting scholars to conduct research in China. The details of specific research proposals will be determined by the mutual agreement of both Parties.
- (4) Any Intellectual Property Rights resulted from the cooperation will be discussed and arranged in separate agreement.
- (5) The parties agree to identify opportunities for commercialization of Intellectual Property.

ARTICLE 3

CONTRIBUTION AND IMPLEMENTATION BY PARTIES

- (1) Before these activities in the Article 2 are implemented, the Parties shall involve to the satisfaction of each Party and enter into an Agreement of Implementation identifying the rights and obligations of each Party.
- (2) In accordance with the prevailing laws and regulations in Indonesia and China, and subject to personnel and budget limitations, the Parties shall assign qualified experts and lecturers to assist in the implementation of activities under this MOA.

ARTICLE 4

AMENDMENTS, EFFECTIVE DATE, DURATION, AND TERMINATION

- (1) This MOA can be amended by mutual consent of the Parties. Any amendments to this MOA can only be made in writing and after consultation and mutual consent of the Parties. Such amendments, once approved by the Parties, will become part of this MOA.
- (2) The effective date of this MOA shall be later date on which the Parties sign this MOA.
- (3) This MOA shall remain in force for a period of **5 (five)** years from the date of the later signature.
- (4) The MOA may be terminated by either Party by giving written notice at least 6 (six) months in advance to the other Party. The event of termination will not affect participants from completing their activities at the host Party.

- (5) The Parties jointly follow up this MOA in the form of Agreement of Implementation (AOI) made no later than 6 (six) months after the signing of this MOA.
- (6) In case the MOA ceases to be effective on the account of termination or expiration, the provisions of all valid agreements signed as addenda to this MOA shall continue to apply to the extent necessary to secure the implementation of existing activities as agreed upon in the MOA documents.
- (7) This Agreement is created in duplicate in English, each of those duplicates being deemed original. In case this agreement is translated into other languages than English, and in the vent of conflict between the English and the alternative version, the English version shall prevail.
